Upcoming SCRUB Events

The Des Moines Public Works Department presently plans to host SCRUB events monthly from July through November. So even though the April SCRUB at Hoover High School was canceled due to COVID-19, there are still opportunities for Des Moines residents to get rid of unwanted trash, junk, hazardous waste and yard debris free of charge.

SCRUB stands for Spring Clean Up to Reduce Urban Blight (SCRUB). Efforts Continue to Reinvigorate Merle Hay Commercial Corridors

In addition to longstanding efforts to support affordable housing and improve our neighborhood's housing stock, MHNA has been persistently advocated for formal planning efforts to revitalize our neighborhood's commercial corridors.

MHNA members have had positive discussions in recent years with business leaders and city officials on how we can work together on plans to continually improve commercial areas on Merle Hay Road, Hickman Road, and Douglas Avenue. A series of stakeholder meetings held between 2015-2016 culminated with a formal request for planning assistance that was submitted to the Des Moines City Council in January 2017. Priorities highlighted in the request included:

- Storm water infrastructure improvements in the vicinity of Merle Hay Road and Douglas Avenue.
- · Median improvements, including brick inlays, stamped concrete, or other decorative elements.
- · Sidewalk installation and reconstruction to improve pedestrian safety and access to commercial areas.
- Improved traffic flow and pavement restoration.
- Targeted beautification and opportunities for public art where practical.
- "Welcome to Des Moines" signage at key entry points.

MHNA members reaffirmed their commitment to improving our commercial areas by passing a supportive resolution at our annual meeting in January 2020. The resolution urged city leaders to budget accordingly so we can formalize planning efforts, which are critical not just to the Merle Hay neighborhood, but the Des Moines metropolitan area as a whole.

We have been fortunate to see some key improvements and commercial redevelopment projects in our area over the past decade. A focused and organized approach to planning what comes next will benefit residents and businesses alike. MHNA will continue to do its part to further this effort, and we encourage everyone to support us and get involved.



Pet Reminders

MHNA occasionally hears from residents who have questions and concerns about their neighbors and their pets. While some of us think of our four-legged friends as family members, it is important to remember that not everyone feels the same way. After listening to some differing perspectives and reviewing the city code, we want to share these quick reminders.

• All cats and dogs residing in the city limits must be licensed

• When walking a dog in public, your leash cannot be longer than six feet

• When a pet goes "No. 2," owners are required to clean up after them, even on their own property.

Also, while the latest info from the CDC says the risk of a pet spreading COVID-19 is "low," it is still good to practice healthy habits around pets. Remember to wash your hands and maintain good hygiene around both people and pets.


City of Des Moines Stormwater Best Management Practices Program

Many of us still remember the helpless feeling of having our properties inundated with stormwater during the historic flood of June 2018. If you still wonder what else you can do to help protect your property and support broader flood mitigation efforts, we encourage everyone to check out the City of Des Moines' Stormwater Best Management Practices Program. Under the program, the City provides recommendations that residents can implement to help improve the water quality of stormwater runoff and/or decrease the amount of stormwater runoff that enters the City's stormwater drainage system.

Through the program, the City will reimburse 50% of the cost (up to \$2,000) to the property owners who meet program requirements. The reimbursement for approved work will be by direct payment to the property owner in the amount of the qualifying work. The work must have been performed and completed between the dates of January 1, 2017, and June 30, 2023, to be eligible for the subsidy program.
