#### **Traffic Safety Updates**

56th Street The speed limit on 56th Street between Frank-lin and University avenues was recently lowered to 25 mph by the Des Moines City Council. The council made the change in response to a request from the Merle Hay Neighborhood Association, which followed a resolution of support that MHNA's general membership approved in October. MHNA also asked city traffic engineers to assess prospects for adding a four-way stop somewhere along this stretch of 56th Street, in hopes it would help cut down on speeding. The necessary traffic studies are expected to occur in the spring. MHNA would like to thank Ward 1 City Councilman Bill Gray for helping get the speed limit lowered.

**50th Street** MHNA fielded concerns at its October quarterly meeting about speeding and illegal parking along 50th Street between Hickman Road and Franklin Avenue. A resident reported that in addition to frequent speeding, some Tower Park-users parked vehicles on the grass at the park, sometimes blocking the sidewalk that runs along 50th Street.

In response to the resident concerns, MHNA contacted Des Moines Police and the Park and Recreation Department. Within a week or two of MHNA's request, police set up a speed trailer on 50th Street. Park and Recreation staff contacted recreational sports leagues that use the park and instructed them NOT to park in the grass or onthe wrong side of the street. Please call police at 283-4811 if any of these problems are observed in the future. MHNA would like to thank police and parks staff for their help on these issues.

### MHNA Leads Successful Food and Clothing Drive

MHNA held its first-ever food and clothing drive on December 15 at the Northwest Community Center. We are pleased to report that MHNA collected over 250 food items, which were donated to the Des Moines Area Religious Council's (DMARC) Food Pantry program. A few dozen winter clothing items—stocking hats, gloves, scarfs, coats, and snow boots—were also collected and donated to Hillis Elementary School.

The need for food donations in particular goes year-round. MHNA will gladly accept food donations at each of our quarterly membership meetings. #### Cell Tower Project at 4800 Douglas Avenue

A proposed cell tower on the grounds of the Des Moines Fire Station at 4800 Douglas Ave. has recently generated a lot of discussion and some media coverage . Here are some key details:

- MHNA's general membership had a lengthy discussion about the matter at our October meeting. Members voted that the site was inappropriate for a standard cell tower with spread antenna arrays. That is because the fire station is almost nine acres less than what city ordinance requires for cell towers, and the site is surrounded by single-family residential property. If a tower was built at the site, members voted that it should be a "stealth" monopole with antenna equipment hidden inside the pole.
- MHNA members also voted that if a cell tower is built quality fencing and landscaping should surround its base. Members expressed a preference for a cell tower in a more predominately commercial area, such as the proposed Hy-Vee near Douglas and Beaver. (A cell tower is already located there.)
- Late in 2014, the Des Moines Zoning Board of Adjustment approved a roughly 178-ft tower with "flush-mounted" antennas. The City Council still has to approve a lease with the cell company.
