Urbandale Avenue Tree Planting

Keep an eye out for beautification efforts along Urbandale Avenue this fall! The City of Des Moines Forestry Division will be planting approximately 40 trees in the medians along Urbandale Avenue between Merle Hay Road and 48th Street. The trees will include a wide variety of overstory shade trees and understory ornamental trees, some unique to the area. The vision is to create a "walking arboretum" along Urbandale Avenue through the Merle Hay and Beaverville Neighborhoods.



This fall's tree planting is intended to be the first phase of a larger effort to restore the tree canopy along Urbandale Avenue. City staff have identified areas to plant an additional 60 trees in the city-owned right-of-way, which is the area between the curb and sidewalk. While the City will plant the trees at no cost, they ask that adjacent homeowners assist with watering. The Forestry Division will be reaching out to adjoining homeowners in the upcoming months, with the goal of planting additional trees in the spring. MHNA strongly encourages homeowners to support the tree-planting plan.

Recycle Right!

Did you know that plastic bags and wrappers cannot be recycled in your blue single-stream recycling cart? Nor can pizza boxes, styrofoam, rubber hoses, tupperware containers, or aluminum foil?

When these items are thrown in your blue cart, it ultimately costs the city money through increased processing expenses. To cut down on bad recycling, Des Moines Public Works has begun conducting curbside audits. In August, they rejected more than 650 recycling carts after spot checks identified non-recyclable materials inside. If your cart was left on the curb, this may be why.

Items that are accepted include paper, cardboard, milk and juice cartons, aluminum and steel cans (including aerosol), glass jars and bottles, yogurt containers, and plastic bottles/containers with twist-off lids. Plastic grocery bags can be returned to your grocery store drop-off sites.

Snow Ordinance Reminders

It’s hard to believe, but winter is just around the corner. Chances are good you may need a quick refresher on the city’s snow ordinance. Here are the basics:

- City ordinance requires vehicles to be removed from snow routes while Public Works crews plow streets. Violators will receive a \$35 fine and can also be towed.
- Once snow routes are cleared, city crews plow residential streets.
- Front-yard parking is illegal at all times.
- Complete details on Des Moines’ snow ordinances can be found at www.dmsnow.org.

Please do your part to help city plow crews keep our streets as clear of snow and ice as possible.

Also, below are some reminders about the city’s requirements for snow removal on sidewalks. As always, MHNA encourages neighbors to help each other with snow removal. Please lend a hand to elderly or disabled neighbors who may not be able to clear their own sidewalks. Thanks to everyone for your help!

- City ordinance requires sidewalks to be shoveled 48 hours after a measurable snowfall.
- Sidewalks should be shoveled full length and width, according to the City of Des Moines.
- Those who don’t clear their walks could be penalized. Historically, fines for noncompliance have been \$50 for the first offense, \$75 for a second violation, and \$100 for a third.
- City ordinance prohibits snow from being blown or thrown into the street.
- Pedestrian ramps on street corners should be shoveled.

City Aims to Strengthen Area Near 48th & Franklin Avenue

City officials recently contacted the Merle Hay Neighborhood Association to share preliminary details of a plan to boost investment in the vicinity of 48th Street and Franklin Avenue. The area at the crossroads of the Merle Hay, Beaverdale, and Waveland Park neighborhoods is one of four pilot areas in Des Moines that the city has targeted for concentrated investments, aiming to make them stronger and more desirable. The approach is similar to investments that helped transform downtown, city officials said.

The proposal was approved by the City Council on September 24, and is a part of a broader update to the city’s Neighborhood Revitalization Program. A roughly six-month planning process will begin in November, affording residents, businesses, and other stakeholders a chance to get involved.

MHNA looks forward to participating and encourages everyone to get involved. We will provide updates as more information becomes available.
